▼ 10 Or 10 Oceanus Pro Classic Trial Offer - Terms and Conditions

- Available to potential MarineNav distributors when purchasing a standard MarineNav Oceanus Pro Classic ROV system.
- Offer extended to potential distributors on approved credit and with an approved Authorized Distributor application submission. Potential MarineNav distributors are to provide a purchase order for the ROV system purchase at the current full dealer price, indicating the discount offer to be applied (if paid within the allowed 30 day term agreement). Refundable deposit due at time of purchase order. The ten-day trial period begins when shipment is received as recorded by the shipment tracking number. The ten ROV operational hour trial period is recorded and tracked by the Oceanus ROV operating system software.
- The 10 or 10 Oceanus Pro Classic trial offer only applies to a standard Oceanus Pro Classic ROV system and does not extend to the Oceanus Mini Lite, Oceanus Mini, Oceanus P8 Pro or Oceanus Ultimate ROV systems. The standard Oceanus Pro Classic ROV system ships with one (1) Oceanus Pro Classic ROV, one (1) Oceanus Pro Classic Topside control case, and one (1) standard Oceanus Hand Controller (v3.0). A 40-meter demo tether is supplied, but is not included as part of the standard Oceanus Pro Classic ROV system. Upon the successful purchase of a standard Oceanus Pro Classic ROV system the demo length of ROV tether is to be shipped back to MarineNav with the potential distributor responsible for all associated costs.
- At ten days, or 10 ROV operation hours (whichever comes first) either return the ROV system in original packaging, or pay your invoice in full within 30 days to receive a 25% discount off of the current listed dealer pricing for a standard Oceanus Pro Classic ROV system. The 10 or 10 Oceanus Pro Classic trial 25% offer is not extended to new standard or custom ROV tether lengths, nor are ROV accessories included in this offer (this applies to all MarineNav or third-party manufactured ROV accessories).
- A full refund is available to potential MarineNav distributors that meet the terms of this agreement, and upon MarineNav Ltd receiving the original shipped ROV system returned undamaged, in its original packaging.
- The potential MarineNav distributor is responsible for all shipping and transit costs, including freight, customs, duties, tariffs, taxes, storage fees, and other related charges, both for shipping to the client location and in the event of return, for those charges as well. The potential MarineNav distributor is responsible to inform MarineNav Ltd of any necessary import permits, licences, and related documentation or paperwork, and to provide whatever details are required in order to facilitate timely shipment.

* Three Year Limited Warranty - Terms and Conditions

MarineNav's Three Year Limited Warranty applies to customers who have purchased one of the following ROV systems; an Oceanus Mini, an Oceanus Pro Classic, an Oceanus P8 Pro, or an Oceanus Ultimate ROV system. An initial two-year limited warranty is made available when your eligible MarineNav Oceanus ROV is registered within the first year of purchase. For the warranty to remain valid all regimented ROV scheduled maintenance must be completed according to manufacturers guidelines. At the completion of the initial two-year limited warranty period a third year extension is provided to those customers who have adhered to all regimented ROV maintenance as outlined by manufacturer. Warranty restrictions apply;

- a) MarineNav Ltd warrants that tether supplied with ROV systems or supplied separately will be free from defects in materials and workmanship under normal use and service for a period of ninety (90) days from date of shipment.
- b) MarineNav Ltd warrants that tether whips that were provided as part of an ROV system at time of original shipment will be free from defects in materials and workmanship under normal use and service for a period of six (6) months from date of shipment.
- c) MarineNav Ltd warrants that thruster motors that were provided as part of an ROV system at time of original shipment will be free from defects in materials and workmanship under normal use and service for a period of one (1) year from date of shipment. This does not include wearable parts such as propellers, which are considered a consumable item. Tampering, misuse and regular wear are not covered by warranties.
- d) MarineNav Ltd warrants that the ROV float block that was provided as part of an ROV system at the time of original shipment, or purchased separately will be free from defects in materials and workmanship under normal use and service for a period of three (3) months. The three-month warranty does not cover normal wear such as scuffs, scrapes indentations, or other damage to the float block caused by external environmental factors.
- e) MarineNav Ltd warranties exclude corrosion that may occur on ROV metallic parts caused in part by improper cleaning and storage of ROV after each mission. Refer to your owner's manual for proper cleaning and maintenance of your ROV system.
